Description

This policy describes the medical necessity guidelines for Testosterone Testing.

Policy/Criteria

- I. It is the policy of Coordinated Care of Washington, Inc., in accordance with the Health Care Authority's Health Technology Assessment, that testosterone testing is considered **medically necessary** for either of the following:
 - A. Assigned male at birth age 19 and older for any of the following:
 - 1. Suspected or known primary hypogonadism,
 - 2. Suspected or known secondary hypogonadism with organ cause, e.g.,
 - i. Pituitary disorders
 - ii. Suprasellar tumor
 - iii. Medications suspected to cause hypogonadism
 - iv. HIV with weight loss
 - v. Osteoporosis
 - 3. Monitoring of testosterone therapy
 - B. As part of the treatment for gender dysphoria when being treated with with one of the following:
 - 1. Hormone replacement therapy
 - 2. Hormone suppression therapy
- **II.** These guidelines do not apply to individuals assigned female at birth or individuals assigned male at birth who are age 18 and younger.

Background

This policy is based entirely on Washington State Health Care Authority (HCA) Health Technology Assessment (HTA) and Health Care Authority Billing Guidelines.
