Coordinated Care of Washington, a managed care organization (MCO), will provide Apple Health coverage for young adults who are alumni of foster care.

The Washington State Legislature directed the Health Care Authority (HCA) to enroll alumni of foster care, and children and youth in foster care, adoption support, extended foster care into an MCO.

Here are a few of the services you can expect from Coordinated Care:

- Help finding the right kind of care for your unique health needs.
- A dedicated phone number and Apple Health Foster Care (AHFC) program staff will be available to assist you with any questions: 1-844-354-9876.
- Education and assistance during the transition from foster care to independence, so you won't lose needed health care services.
- A Nurse Advice Line and a dedicated phone number for you to call 24/7. You can talk to your health care coordinator by phone during business hours and by voice mail 24 hours a day.
- Additional services to support better health outcomes like access to an online health library, wellness programs, maternity program, no-cost cell phone, and more.



Be sure to keep your ProviderOne card because you will still need it to pay for some health care related services.

Here's a list of some of the services* you may be eligible for:

Coverage by Coordinated Care

- Physical health
- Moderate behavioral health
- Eye examinations
- Specialty providers
- Pharmacy
- Hospital
- Durable medical equipment
- Emergency services

Coverage by ProviderOne Services Card

- Dental
- In-patient behavioral health
- Eye glasses (up to age 21)
- Transgender health services
- Transportation for medical appointments

Did you know?

You may be eligible for free health care until age 26 if you were in foster care.

- The Affordable Care Act (Obamacare) extended health care insurance benefits for former foster youth until your 26th birthday.
- You're eligible for AHFC Alumni program if you left the foster care program on or after your 18th birthday.
- To enroll, contact the Health Care Authority (HCA) Foster Care Medical Team (FCMT) at 1-800-562-3022, extension 15480.
- If you've moved recently, please call the FCMT with your new address.
- If you have not turned 26 and do not have health insurance, contact the FCMT to see if you are eligible.
