Description

This policy describes the medical necessity guidelines for stem cell therapy for musculoskeletal conditions.

Policy/Criteria

I. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, in accordance with the Health Care Authority's Health Technology Assessment and Health Care Authority Billing Guidelines, that stem cell therapy is **not medically necessary** for the treatment of musculoskeletal conditions.
