



Clinical Policy: Cardiac Stents

Description

This policy describes the medical necessity guidelines for drug eluting or bare metal cardiac stents.

Policy/Criteria

- I. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, in accordance with the Health Care Authority's Health Technology Assessment, that cardiac stents for treatment of stable angina are considered **medically necessary** when all of the following are present:
 - A. Angina refractory to optimal medical therapy, and
 - B. Objective evidence of myocardial ischemia

Background

This policy is based entirely on Washington State Health Care Authority (HCA) Health Technology Assessment (HTA) and Health Care Authority Billing Guidelines.
