

Clinical Policy: Tympanostomy Tubes in Children

Description

This policy describes the medical necessity guidelines for tympanostomy tube insertion.

Policy/Criteria

- I. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, in accordance with the Health Care Authority's Health Technology Assessment, that tympanostomy tubes are **medically necessary** for *children aged 16 years or younger with acute otitis media (AOM)* when one of the following criteria are met:
 - **A.** Member/enrollee has complications of the AOM, is immunocompromised, or is otherwise at-risk for infection, or
 - **B.** Three episodes of AOM in the last 6 months and presence of effusion at the time of assessment for surgery.
- II. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, in accordance with the Health Care Authority's Health Technology Assessment, that tympanostomy tubes are **medically necessary** for *children aged 16 years or younger with otitis media with effusion (OME)* when one of the following criteria are met:
 - **A.** Duration of effusion is 3 months or greater and documentation of hearing loss, or
 - **B.** At disproportionate risk
 - a. For persistent effusion based on anatomical anomalies or
 - b. From the effects of hearing loss, such as speech delay, underlying sensory-neuro hearing loss or cognitive disorders.

Background

This policy is based entirely on Washington State Health Care Authority (HCA) Health Technology Assessment (HTA) and HCA Billing Guidelines.
